## **PCP Show**

PCP dates at Linn County FG are Aug 26<sup>th</sup> thru Sunday 30<sup>th</sup>. You can arrive on Tues. Wed will be English, Thursday will be Western, Fri will have Halter for both halves of the show. You will show Halter in the Morning to the first set of Judges. A break will be taken the second set of judges will be brought in and halter starts over for the second half of the shows. Sat will be English, Sunday will be Western.

It is proposed to PCP that the Halter futurities will return. The Fee will be 25.00 the Futurities will run concurrent with classes. The Points for both halves of the show will be calculated to determine the winner. This needs to be passed by the PCP committee. Joni Osborn made the motion, Kathy Thomas second the motion.

It has also been proposed to the PCP that the riding futurities come back. Again a 25.00 fee, the Futurities would run concurrent with the classes for both halves of the show. It is proposed that there is one English Riding futurity, and one Western Riding futurity. The motion was Made by Niki Yates and second by joni Osborn.

It is also proposed that at PCP we will try to have a Plaque or Horse Head statue be given to the average class winner of each class. This was proposed by Wendy Davidson, 2nd by Shana Rollins and will be discussed at the PCP meeting.

PCP has approx. 30,000 in its account.

Wendy Davidson reminded us to work on corporate sponsors for the PCP. She will contact Kensington and some of the other Pinto Sponsors to see if they will sponsor the PCP show.

#### **General Club Talk**
